- 5. Payment requirements.     a) \$200.00 retainer due with return of contract in 15 days,  
  b)Balance in full due one week (7 days) before scheduled event.

6. The Leader shall assign entertainer/s to each event as required, and carry out instructions as to selections and manner of performance. Special requests for music and songs should be made atleast two weeks prior to the event to guarantee inclusion in the music program. The employer guarantees a sturdy six-foot table, and ample power for the operation of atleast the sound equipment of the entertainer.

7. The agreement of Infinity-Lighthouse to entertain is subject to proven detention by sickness, acts of God, mechanical, electrical, electronic failure, or any other legitimate condition beyond the control of the Leader or the assigned entertainer. If the event has to be cancelled due to any of the above reasons, Infinity-Lighthouse will try to find a replacement entertainer or refund all payments received from the employer, and will work with the employer to reschedule the event at a later date for the same contracted wage.

8. The employer will be held fully responsible for any and all damages or injuries inflicted on the equipment or entertainers of Infinity-Lighthouse, by the patrons of the employer or the establishment thereof. In the case of concurrent engagements, the employer is responsible for the safe keeping of the equipment of Infinity-Lighthouse left at the establishment of the employer.

9. This contract may be cancelled by the Leader or the Employer. Notice of cancellation must be made in writing and mailed with the original copy of the contract to the Leader of Infinity-Lighthouse sixty (60) days before the event, thereafter the employer is liable for the entire contracted wage. If the Employer breaches this contract, he/she shall pay in addition to damages, ten (10) percent interest thereon, plus our attorney's fee.

10. There is a \$50.00 (fifty dollars) late fee for late payments. The Employer shall be liable and responsible for the balance payment under this contract.
